The Board of Education of Unified School District 248 met in the Board Office on Thursday, December 11th, 2025. President, Dave Goble, called the meeting to order at 6:30 pm. Roger Breneman moved, Kelly Peak seconded the motion for the approval of the agenda; approval of the minutes from the November 13th, 2025 Board Meeting, approval of the treasurer's report and the bills be approved for payment, amounting to \$1,080,060.00. Motion carried 6 – 0.
