The Board of Education of Unified School District 248 met in the Board Office on Thursday, November 13th, 2025. President, Dave Goble, called the meeting to order at 6:30 pm. Henry Ashbacher moved, Roger Breneman seconded the motion for the approval of the agenda with the additions #8I-Donation, #15 A and B-Facilities/Maintenance Update; and #17B Resignation; approved of the minutes from the October 9 2025 Board Meeting, approval of the treasurer's report and the bills be approved for payment, amounting to \$1,549,621.74 Motion carried 7 – 0.
