NOW, THEREFORE, BE RESOLVED by USD 248 that the 2025-2026 budget with a levy of property taxes exceeding the Revenue Neutral Tax Rates calculated for 2025-2026, as adjusted pursuant of K.S.A. 79-2988 is hereby adopted.
